4. First-aid measures	<p>Eye contact: Rinse thoroughly with plenty of water for several minutes. If symptoms persist, seek medical advice.</p> <p>Skin contact: Rinse affected area with water. If needed apply cold compress to relieve irritation. If symptoms persist, discontinue use of product and seek medical advice.</p> <p>Ingestion: Drink a glass of water to dilute product. Do not induce vomiting. Act immediately in order to prevent further irritation of mouth, throat and stomach mucosa.
